# Transition Planning Information



#### **Planning for the Future**

Transition planning is an essential component of your child's educational experience. The planning process begins officially when students turn 12 years old, continues throughout his/her entire school experience, ending with a student exit summary prior to completing the program or reaching age 21. To help prepare your child for a successful future as an adult, families should start engaging in the transition process as early as possible.

#### The Importance of Transition Planning for Students with Developmental Disabilities

All students need guidance and support to make the leap from high school to the adult world. Students with developmental disabilities, however, need even more help because their leap is that much greater. Transition planning provides a personalized course of action based on students' individual strengths, needs, interests, desires and dreams for a fulfilling life.

How Parents and Guardians Can Best Support Transition Planning One of the best ways to support the transition process for your child is to have your child evaluated for **eligibility** with the Office for People with Developmental Disabilities (OPWDD) as early as possible. Once an individual is determined to be OPWDD eligible they get a Care Manger who will facilitate their connection to a supportive agency who can provide services.

## What is Eligibility?


People who have developmental disabilities can apply for OPWDD supports and services. These supports and services are meant to provide help throughout life for people with the greatest level of need for supports. Each person who wants OPWDD supports or services has the right to an individual eligibility review. That review will determine whether he or she has a condition that qualifies – or makes the person "eligible" for services and supports from OPWDD.

## Who Determines Whether Someone is OPWDD Eligible?

Only OPWDD can determine whether a person meets all of the conditions and requirements of eligibility for OPWDD-funded services.

## What is Needed to Determine OPWDD Eligibility?

In order to determine OPWDD eligibility your child will need two evaluations-a Psychological Evaluation (to determine intellectual functioning) and a Psychosocial Evaluation (to determine social development). Additionally, a medical report indicating your child's health status in required and a certificate indicating parent/guardian attendance at an OPWDD Front Door Informational Session are needed.



#### A Look at the OPWDD Eligibility Process

When is the Best Time to Start the Process of Determining OPWDD Eligibility?

It is never too early to determine eligibility. In fact, the early the better because once a student is found eligible and is waiver enrolled, they are able to take advantage of the many services and supports available to them.
